SOLICITOR MEADE READS ARTICLE XIII (R-1) "OLD VILLAGE" RESIDENTIAL DISTRICT Section 13.01 Purpose The R-1 District is established to provide for the continuance of single family housing within the older portions of the Village of Sugar Grove. The R-1 District allows for expansion of such uses at densities consistent with

existing development, thereby encouraging private reinvestment and revitalization and increasing the diversity of housing choice while maintaining adequate development standards.

READING THROUGH THE APPLICATION VS. THE ACTUAL ZONING ORDINANCE OF THE VILLAGE.

THE USE OF THE R1 STATUS. 6.01.02 EXCEPTIONS MAY BE GRANTED, BUT THE STATED PURPOSE OF THE R1 DESCRIBES THE PURPOSE IN THE FIRST SENTENCE IN THE ABOVE WRITTEN R1 DESCRIPTION. IF ONE MULTIFAMILY DWELLING IS ALLOWED, WHEN WILL IT BE STOPPED. WHAT IS DONE FOR ONE WILL BE DONE FOR ALL, THEREFORE

TWO FAMILIES LIVING INDEPENDENTLY, BUT AS ONE. OTHER COMMUNITIES ALLOW THIS

SMALL SECTION OF THE VILLAGE HAS ITS OWN ORDINANCE THAT WILL ALLOW MULTI FAMILY DWELLING
